1 Proposed Constitutional Amendment, creates a bipartisan public process for drawing congressional districts

2 Mahoning County renewal for the purpose of care, treatment and maintenance of residents who suffer from tuberculosis and related diseases at 0.1 mill for 5 years

Austintown Township replacement and increase in the amount of 0.8 mill for the purpose of operations of the police department at 3.2 mills for a CPT

Boardman Township a replacement and decrease in the amount of 0.3 mill for the purpose of current expenses at 2.9 mills for 5 years

Jackson Township an additional tax for the purpose of providing and maintaining fire apparatus at 1.4 mills for 5 years

Smith Township (excluding Beloit Village) for the purpose of current expenses at 2 mills for 5 years

Alliance City additional tax for the purpose of parks and recreational at 3 mills for 5 years

Alliance City School District renewal of 7.7 mills for emergency requirements for 10 years

Boardman Local School District additional tax of 5.8 mills in the sum of \$4,900,000 for the purpose of emergency requirements for 10 years.

Western Reserve Local School District renewal of 4.1 mills in the sum of \$425,000 for the purpose of avoiding an operating deficit for 10 years
