(1) Mahoning County Renewal of the Sales and Use Tax (Justice Tax) 3/4 Percent for 5 years Renewal

Campbell City Schools renewal in the sum of \$989,711 16.3 mills for the purpose of providing for emergency requirements for 5 years.

Springfield Local School District renewal a 1 percent income tax for the purpose of current expenses for 5 years

Weathersfield Local Schools renewal in the sum of \$418, 128, 3.65 mills for the purpose of providing for the emergency requirements for 10 years

West Branch Local Schools additional income tax in the sum of \$850,000 at 0.5% for 5 years for the purpose of school district purposes
